The 2014 Synod Assembly of the Delaware-Maryland Synod of the Evangelical Lutheran Church in America was opened at 10:00 a.m. on May 30th in the Roland E. Powell Convention Center, Ocean City, MD.

FIRST BUSINESS SESSION Friday, May 30, 2014 10:00 a.m. – 12:30 p.m.

Members participated in the "Opening of the Assembly," followed by Bible Study on Ephesians 4:1-16, led by Pr. Karen Brau, Assembly Chaplain, from Luther Place Memorial, Washington, DC.

Bp. Herz-Lane welcomed everyone to the assembly and introduced the three-year theme: Walking together in Christ, Evangelism, Leadership, Mission. This year the focus is "Mission."

Special Guests introduced included: Rev. Stephen Bouman, ELCA Representative, Rev. Karen Brau, Assembly Chaplain, Rachel Kurtz, Music Leader, and members of the synod council. Bishop Wolfgang Herz-Lane, using an analogy of the movie, "The Titanic," shared thoughts on what actions happened when the ship hit the iceberg and how the church needs to react as it continues to face the iceberg of a changing world, declining membership, and interest in the church. "If we keep on doing what we've done, we'll continue to get what we've always gotten."

Bp. Herz-Lane offered that the ship of the church is starting to turn away from the iceberg and listed a variety of ways that God is working in the synod and what good things are happening. "With God all things are possible."

A Call for a Coordinator for the African Descent Strategy of the Delaware-Maryland Synod

WHEREAS the Evangelical Lutheran Church in America adopted and approved the

"Plan of Action for Ministry in African Descent Communities," on August

11, 2005, at its Churchwide Assembly; and

WHEREAS the various mission goals in this strategy challenge people of African

> Descent within Lutheranism to live out in a variety of ways and through various callings the will of God which promotes justice, healing and

human dignity for all; and

WHEREAS a Strategic Plan of the Delaware-Maryland Synod for congregations

> within the African Descent Communities on its territory was approved by the Synod Council on May 15, 2010, and subsequently approved by the

Synod Assembly, 2010; and

WHEREAS the strategy offers a vision and plan of action that guides efforts to

provide leadership and support to the Delaware-Maryland Synod and congregations as they reach out in witness to the gospel with and among peoples of African Descent, and to provide a framework for monitoring and evaluating the effectiveness of the programmatic activities in developing new congregations and in supporting established congregations and engaging visionary leaders in the church; and

WHEREAS an African Descent Strategy is vital for the sustenance, growth, and

understanding of African Descent Lutheran congregations in

urban/suburban communities of the Delaware-Maryland Synod; and

WHEREAS an African Descent Strategy provides a platform for voices, experiences,

and perspective of the underrepresented in the membership of the

Delaware-Maryland Synod; and

WHEREAS to accomplish the goals as outlined in the above approved strategy a

part-time Coordinator is essential; and

WHEREAS the full participation and financial support of the Delaware-Maryland

Synod is required to successfully execute the strategy as agreed upon by

its voting members at the 2010 Delaware-Maryland Synod Assembly;

THEREFORE, BE IT RESOLVED that the Delaware-Maryland Synod act on the resolution passed during the 2010 Synod Assembly;

BE IT FURTHER RESOLVED that a person be engaged by the Synod Council of the Delaware-Maryland Synod as a part-time Coordinator of the African Descent Strategy in agreement with the understanding of "full participation and financial support" of the Delaware-Maryland as recommended and agreed upon in the original resolution "beginning with the 2012 Faith Spending Plan;"

BE IT FURTHER RESOLVED that the Office of the Bishop in consultation with Churchwide Partners, the Budget Development Committee of the Delaware-Maryland Synod, and other existing synod committees identify financial support of \$18,000 per year for a three-year term engagement of a Coordinator for the African Descent Strategy on behalf of the Delaware-Maryland Synod to support our efforts as the Evangelical Lutheran Church in America to become more inclusive and representative of all of God's people.

WHEREAS Super Storm Sandy (October 29-30, 2012) caused considerable damage

to lives and homes in Somerset County, MD, and

WHEREAS the Delaware-Maryland Synod and its congregations, Lutheran Disaster

Response, Diakon Lutheran Social Ministries, Lutheran Partners in Disaster Response and many congregations of the Southeastern District of the Lutheran Church, Missouri Synod have been supportive of the

Recovery Effort, and

WHEREAS the Rev. Phillip C. Huber, and the Rev. Thomas G. Sinnott, representing

Lutheran Disaster Response and Lutheran Partners in Disaster

Response, have been instrumental in helping form the Somerset County

Long Term Recovery Committee (SCLTRC), Inc., (a 501(c)(3) organization) and coordinating the long term recovery effort, and

WHEREAS the SCLTRC is composed of an ecumenical, faith-based and non-profit

partnership, which includes Episcopal Disaster Relief, Mennonite Disaster Services, American Red Cross, United Methodist Committee on Relief, the United Way, International Orthodox Christian Charities, Baptist Convention of Maryland and Delaware, Catholic Charities, Chesapeake

Conference of 7th Day Adventist, 31 other partner agencies, and

WHEREAS the SCLTRC has a staff of seven persons (Case Manager, Case Worker,

Office Administrator/Volunteer Coordinator, Manager of Construction Operations, Construction Superintendent, Data Technician, Volunteer

Camp Manager), and

WHEREAS to date the SCLTRC and its Staff have:

- Engaged over 1,000 Disaster Volunteers
- Served over 700 individuals and 361 families
- Repaired over 175 homes
- Built 5 new homes
- Presently constructing 6 new homes
- Have 12 new homes remaining to be built
- Have over 65 homes remaining to be repaired, and

WHEREAS Lutheran Disaster Response has recently provided \$207,000 in staff

support funding for the first 9 months in 2015 which establishes the date of September 30, 2015 as the ending date of our long term recovery

efforts in Somerset County, and

WHEREAS there is a projected \$360,000 shortage in funding needed to complete the

recovery effort in Somerset County, and

WHEREAS we are now half-way through the long term recovery effort and need a

surge of energy and resources to complete the ministry we have been

called to:

THEREFORE, BE IT RESOLVED that the Delaware-Maryland Synod Assembly encourages its congregations, agencies and institutions to renew their support of the ongoing rebuilding efforts in Somerset County by offering their financial support, prayers, and

BE IT FURTHER RESOLVED the Synod Assembly recognizes the opportunity for mission in Somerset County, MD by encouraging its congregations to send work crews, work camp cooks, and long term recovery office volunteers to Somerset County to assist in the reconstruction efforts.

signposts: Way of Discipleship, Way of Communication, Way of Connectedness, Way of Leadership.

The assembly spent time reviewing the plan discussing in small groups what is exiting about this Vision, what will have the greatest impact on your ministry, what is missing. Time was allotted for members to share initial thoughts about the plan.

- **WHEREAS** the church throughout history has not only neglected to address violence/abuse against women but has contributed greatly to patriarchal systems and a culture of silence and victim-blaming which exacerbate this violence; and
- WHEREAS God calls us to recognize, comfort, and advocate for neighbors suffering under systems of oppression: "Again I saw all the oppressions that are done under the sun. And behold, the tears of the oppressed, and they had no one to comfort them! On the side of their oppressors there was power, and there was no one to comfort them" (Ecclesiastes 4:1, ESV); and
- WHEREAS

 Jesus himself put his voice and his body between those who would commit violence/abuse against women, even as they used their faith to justify their actions (John 8:3-11);" and
- **WHEREAS** the Evangelical Lutheran Church in America has taken good steps in providing resources related to "Justice for Women;" and
- **WHEREAS** there is a long-delayed emerging national conversation about violence/abuse against women, and the church cannot remain silent any longer; and
- THEREFORE, BE IT RESOLVED, that this synod confesses our role in supporting systems of patriarchy and misogyny which contribute to a culture of violence/abuse against women by our silence, by our inaction, and by our failure to create safe communities in which survivors of sexual violence and human trafficking can be heard and supported; and
- BE IT FURTHER RESOLVED, that this synod calls upon congregations to engage in conversation and education around violence/abuse against women from a faith-based perspective, and to create space where survivors feel recognized and supported; and
- BE IT FURTHER RESOLVED, that this synod will provide church leaders with training on best practices in responding to and supporting survivors of violence/abuse against women and human trafficking, within or in addition to the existing leadership training and continuing education opportunities offered by the synod; and

BE IT FURTHER RESOLVED, that this synod will engage with and advocate for state and local efforts to address violence/abuse against women, and work to hold state and local authorities accountable for their efforts in this area.

REPORT OF THE ELCA REPRESENTATIVE

Rev. Stephen Bouman, Executive Director of the Congregational and Synodical Mission unit of the ELCA, shared an ELCA video on several ministries, "ELCA in Action, Being Church Together." He acknowledged the commitment of the synod in mission support and support of World Hunger and Lutheran Disaster Response. Pr. Bouman shared the work of the synod and ELCA in new congregations starts, new and renewing congregations, participation on churchwide committees, missionaries, and worldwide growth of the church. Challenges to end hunger and poverty and deal with the immense issues surrounding immigration, especially as the numbers of children/minors entering this country continues to grow, were also provided.

Synod Council Resolution # 4 Regarding the Delaware-Maryland Synod's Participation in "The Campaign for the ELCA"

WHEREAS, St. Paul lifts up "the surprising and generous ways in which God is working in the churches in Macedonia" (2 Corinthians 8: 1, *The Message*), calling the early Macedonian Christians to financially support their brothers and sisters in the mother church in Jerusalem; and

Campaign, including setting goals and developing action steps to reflect the mission needs of the synod in conjunction with the goals of the ELCA Campaign, and be it further

RESOLVED that the bishop, the synod vice president and the treasurer shall serve as ex officio members of the Campaign Action Team to facilitate a coordination of the work of the Campaign Action Team with the overall mission strategy for the synod as contained in the "Vision 2018" plan; and be it further

RESOLVED that the Campaign Action Team shall submit its plan with sufficient time for the Synod Council to review and refine the plan for presentation to the 2015 Synod Assembly for consideration and action.

Synod Council Resolution # 3 Implementation of the "Vision 2018" Synod Missional Plan

WHEREAS, "we take our lead from Christ, who is the source of everything we do. He keeps us in step with each other" (Ephesians 4:16, *The Message*); and

WHEREAS, the 2014 Delaware-Maryland Synod Assembly is asked to consider and adopt the "Vision 2018: Discerning God's Plan" document which seeks to determine the directions of the synod's ministry for the years 2014 through 2018; and

WHEREAS, it is the deep and genuine desire of the Delaware-Maryland Synod in Assembly that this plan be implemented in the life and ministry of our synod so that God's Holy Spirit might lead us in new directions and bring much fruit; and

WHEREAS, in order to fully implement the Vision 2018 Plan, we need to take the core concepts from that vision and move them into strategic action plans; and

WHEREAS, this process involves identifying specific tactics through prioritizing resources, setting measures for success and establishing timelines for completion;

NOW, THEREFORE, BE IT RESOLVED

THAT the Delaware-Maryland Synod gathered in Assembly direct the Synod Council to appoint a five- member team consisting of two staff persons, two Discernment Team members and one Synod Council member; the bishop and the synod vice president will serve ex officio:

AND THAT this Implementation Team be tasked with developing a detailed strategic plan to include specific tactics to implement the intent of the "WAY" together with identifying needed resources, building ownership, setting a time frame for completion and developing additional metrics for measuring success;

AND THAT a first draft of this strategic plan be ready by October 1, 2014 with approval by the Synod Council in November 2014.

REPORT OF THE VICE PRESIDENT

VP Yolanda Tanner shared her experiences during the 2013 ELCA Churchwide Assembly, including, participating in the Installation Service of Bp. Eaton, the agendas of the synod council meetings, including Bible Study, the inner workings of the synod and the ministries of the territory of the synod, and the development of the Vision Plan. She thanked the council members for their commitment and dedication to the work of the synod.

REPORT OF THE SECRETARY

Nancy recommended that two copies of the minutes of the 2013 Delaware-Maryland Synod Assembly of the Evangelical Lutheran Church in America, as certified by the Synod Council, be approved as the official record of the 2013 Synod Assembly and deposited in the archives of the synod.

The minutes of the 2013 were approved by general consensus.

REPORT OF THE TREASURER

Pr. Robert Harvey, synod treasurer, shared that SY2013, income was in excess of expenses by \$71,223. He thanked congregations for their mission support, ensuring the mission and ministries of the synod. Appreciation was shared also for the synod council, synod staff, finance committee.

Pr. Harvey referred to the audit of 2013 Fiscal Activity, February 1, 2014, through January 31, 2014. He presented the letter of certification from the auditors, Klosterman and Associates. The audit has been approved by both the Finance Committee and the Synod Council.

MALARIA CAMPAIGN

Pr. Dave Asendorf shared that the synod has raised \$203,387 as of this assembly for the ELCA Malaria Campaign. He challenged congregations to continue to raise funds for the campaign. Bp. Herz-Lane awarded St. Mark, Wilmington, DE an award for raising the most funds (\$20,000) and was awarded, "Melissa the Mosquito."

MISSION INVESTMENT FUND

Ken Petersen provided information about the Fund: the Fund is financially strong, grants are used for new starts and capital projects, both individuals and congregations can invest in the Fund. He encouraged participation in the Fund.

HUNGER TASK FORCE

The annual awards to congregations raising the most money for the ELCA World Hunger Fund were acknowledged by Deaconness Jean Warren and Rev. Ron Schlak.

- "Tim, the Terrifying" awarded to the smallest congregation with 64 members: Epiphany Lutheran Church, Ellicott City, MD, raised \$6,711.
- "Holy, the Fighting Hunger Blue Hen," awarded to the Community Partners (congregations) in the Frederick Conference.

Sally Kopp reviewed the 2014 Synod Assembly Evaluation and encouraged members to complete the on-line (or paper) versions as soon as possible. Feedback, suggestions, and comments are important to assist the planning committee in working to continually make improvements to the assembly.

Bishop Herz-Lane related that next year's assembly will be a three-day event, held at the Roland E. Powell Convention Center, Ocean City, MD, May 28-31, 2015.

The assembly concluded with closing worship which included the Ordination to the Ministry of Word and Sacrament to Kelly Pensinger, called as pastor to Grace of God Lutheran Church, Millsboro, DE.

Following worship the installation of synod officers, synod council, conference officers, mission team leaders, and consultation and discipline committee members was held.
